**1. Introductions and welcome**

**2. Announcements**

- a. Call for Proposals for the [2019 AASHE Conference](#) (October 27-30, 2019 in Spokane, WA) is now open. Deadline is March 8, 2019. Has anyone submitted or planned a CSU proposal? HDS is planning to submit an Eco Leader independent projects. Idea suggested: to have a submittal related to CSU's Pollinator Friendly Campus Committee accomplishments. Jake shared that he may submit for a Surplus related proposal. Please notify Tonie Miyamoto with other ideas. Would be great to have faculty representation and involvement
- b. The PSC was asked to have an interactive booth at the 1870 Dinner to be held Feb. 9, 2019. Table runners and stand-up banners have been designed and ordered. Four volunteers will represent the PSC; Tonie Miyamoto (PSC), Margarita Lenk (faculty), Ashley Carlisle (student), and Stacey Baumgarn (staff). The table will feature sustainability highlights, accomplishments, and engage attendees to test themselves on recycling and waste sorting skills!

- c. The PSC is seeking a volunteer to provide administrative support. If you are interested in this opportunity, please contact Tonie Miyamoto. Thank you to Tim Brennan for volunteering to fill the PSC Treasurer role!

### 3. STARS 2.2 Launch

Version 2.2 of the Sustainability Tracking, Assessment & Rating System ([STARS](#)) is expected to be officially launched this spring. PSC, on behalf of CSU, is planning to submit an updated STARS report utilizing version 2.2 mid-to-late fall, 2019. Preliminary data collection is kicking off now. This will be CSU's fifth STARS report.

STARS measures sustainability performance in four broad categories: *Academics (Curriculum and Research)*, *Engagement (Campus and Public)*, *Operations*, and *Planning & Administration*. Across those categories, and including *Institutional Characteristics* and *Innovation & Leadership*, there are 69 "credits". Completing a comprehensive 2.2 report will require responses to over 1,000 unique questions. In preparation for this:

- a. Lynn Johnson, Vice President for University Operations, will be giving a heads-up to the CSU President's Cabinet that data collection is beginning. As members of the PSC will be seeking information and support, enabling a comprehensive collection of data and representation from all sections of the university – the PSC will be seeking broad participation and collaboration from all campus stakeholders
- b. To accomplish our mid-fall reporting "deadline", data collection has already started! For example, (agenda item 3.e.) members of PSC representing each College have been asked to help review a list of undergraduate and graduate majors, minors, and certificates focused on sustainability (PSC members will receive reminder email by 1-30-19)
  - AASHE (the creator and administrator of STARS) is introducing an External Reporting Assurance credit with version 2.2. Reports earn extra points when they have gone through a third-party review prior to submittal to AASHE. Third-party review can either be hired or performed in conjunction with two other institutions through a peer-to-peer review process. After much discussion, **it is preferred by PSC members to hire a professional / independent third-party reviewer**. While the intention of peer-to-peer is appreciated, the time, effort, and potential for inconsistent evaluation is high. Co-Chairs Miyamoto and Dollard will prepare a funding request for independent third-party review of our 2.2 report
- c. Setting a goal for CSU's STARS version 2.2 submittal. CSU was the first institution in the world to achieve a Platinum rating in 2015 (STARS version 2.0). CSU repeated as Platinum in 2017 (STARS version 2.1). CSU is the only institution to achieve a Platinum rating twice. What goals should PSC and CSU set to achieve for our 2.2 report?
  - There are currently five institutions with a Platinum rating (including CSU). Should the goal for our 2.2 report be; Platinum, a numeric goal, highest score (yet achieved)?
  - Following brief discussion, **a motion was made by John Fitch with a second by Margarita Lenk to set a goal for CSU to achieve a Platinum rating under STARS version 2.2. Unanimously approved**
  - Further discussion included: it is important to maintain our rating achievement of Platinum. A stretch goal could include achieving the highest U.S. score ever – which is possible – with the implementation of new initiatives, support, and collaboration from all parts of the institution
  - Tonie and Carol will share this goal with Lynn (including the PSC stretch goal) to communicate with Cabinet
  - The STARS core team will review the credit areas with the most opportunity for improvement (from our 2.1 report) and remind the PSC and Lynn of these areas

- d. STARS Team. Previous STARS reports have been compiled by a small core team. If any members of the PSC would like to join this group and contribute to the completion of our STARS 2.2 report, please notify Tonie. This is a voluntary role. It will involve extra work. But, it is fun to be in the mix! The existing team is: Tonie Miyamoto, Carol Dollard, Kirstie Tedrick, Ashley Carlisle, Nik Olsen, and Stacey Baumgarn

  - Future agenda item suggested: revisit and discuss CSU Building Standards – aspects related to and inclusive of sustainability considerations
- b. Which sustainability model(s) from other campuses work best? Topics of conversation to explore: should CSU have a central office of sustainability as the other STARS Platinum institutions do? Continue with our de-centralized but highly collaborative approach? Work as “volunteers” or as/with professional sustainability staff?
